On behalf of the Governor of Tripura, the undersigned invites sealed QUOTATION from bona-fide citizen in plain paper in for "**Maintenance of Computers**" for Jampui Hill R.D BLOCK during the year 2016-17.

The Tender Box will be kept opened for dropping of Tender by the intending Tenderers in the office chamber of the undersigned from **08/03/2017 to 18/03/2017** from 10.AM to 3.00 PM except Govt. holiday and the box will be opened on the last day at 3.30 PM if possible. If the last date of Tender dropping / opening of Tender becomes paralyzed due to any unforeseen reason, the next Working Day will be the last date of Opening of Tender Box.

The interested Tenderers should quote the rates as per prescribed format given below and the rates must not exceed the ceiling rate given in column 5, the rates of the components/parts must be mentioned categorically as per specification. The Tenderers must submit CRC/PRTC, PAN Card, VAT clearance certificate, Tax clearance & residential proof documents as evidence of valid bidder and permanent resident of Tripura along with the Tender. The tender must accompany earnest money of Rs.500/- (rupees five hundred) only in favour of the undersigned payable from any nationalised Bank at Vanghmun.
