Sealed rate quotations are hereby invited on behalf of Government of Tripura by the undersigned from the intending bonafide and resourceful supplier (Indian Nationality) for supply of the pineapple seedling for various work (under MGNREGA) as per terms and conditions indicated below, which will be received in the office of the SDFO, Dharmanagar up to 3.00 PM on 30th November 2016 and will be opened on the same day at 3.30 PM, if possible, otherwise on the next working day at 10.00 am while the bidders may remain present.

Terms & Conditions

1. Bidder should submit up-to-date ITC/PTC & VAT Registration Certificate along with the tender.
2. The bidder should have valid license for trade.
3. The tender will be received by hand/post in sealed cover.
4. Each tender should accompany a "D" call for Rs.10,000.00 (Rupees ten thousand) only drawn in favour of the undersigned on any National Bank being Earnest Money without which no tender shall be treated valid for acceptance.
5. The earnest money of the unsuccessful bidder will be released immediately against prayer from the concerned bidder, while earnest money of the successful bidder shall remain deposited as Security Money till the supply is completed. In case if inability on the part of the successful bidder to affect supply of ordered materials in time, the Security Money shall be liable for forfeiture to the Government.
6. Rate should be quoted for each article separately including all taxes, both in figure and words.
7. The bidder should submit along with quotation details of bank account, PAN card etc.
8. The successful bidder shall be registered as vendor as per rule of MGNREGA.
9. Sales Tax/Income Tax, as applicable, will be deducted from the bill.
10. Payment will be made against bill to be produced on completion of supply of the ordered materials by generating FTOs as per guideline of MGNREGA.
11. Supply is to be made to the site of plantation within ten days from the date of receipt of supply order from this end. If bidder notable to supply within 10 days order will be cancelled.
12. The accepted rates shall remain valid for a period of one year from the date of acceptance of rates.
13. The undersigned reserves the right to accept or reject any tender including the lowest one without assigning any reason.
14. Supply order would be placed in phase manner.
15. Tentative place of supply of the seedling are Churaibari, Panisagar, Damcherra, Bagsassa, North Induril/Halflong/Rahumcherra/Thumsaraipara/Khedacherra/Bangsul offices.
