- 3) The Quotation will be opened at 3.30 pm of 6th Feb, 2017, if possible, in presence of the quotationer or their representative who are willing to attend. The quotationer or their representative who are present at the time of opening of the quotation should sign in the register.
- 4) The Quotationer have to submit attested copies of PAN card and VAT registration certificate.
- 5) The Quotationer are to quote their rates both in words and figures.
- 6) Rate must include of all taxes and charges for necessary loading, unloading, carrying, weighing, counting and staking etc.
- 7) If necessary, total order may be devided amongst more than one bidder at the approved rates.
- 8) Necessary statutory deduction (income tax, VAT etc) will be made from the bill at source and necessary TDS will be provided by the undersigned.
- 9) Bills are to be raised in duplicate to the undersigned through the supervising/implementing Officer after completion of supply.
