The sealed quotation is to be dropped in the Tender Box kept in the Office of the undersigned up to 3.00 P.M. of the 08th August 2017 during all working days. The quotation will be opened at 3.30 P.M. of 08th August 2017 in presence of the quotationer/bidders or their representative who are willing to attend .The quotationer/bidders or their representative who are present at the time of opening of the quotation should sing in the Register.

Terms and conditions:-

- 1) The quotation should be sealed in cover and addressed to the Block Development Officer, Jubaraj nagar R.D.Block, North Tripura.
- 2) The quotationer/bidder have to submit attested copies of PAN card and VAT Registration certificate .
- 3) The quotationer/bidder are to quote their rates both in words and figures.
- 4) Every quotation must be accompanied by an earnest money of Rs. 10000.00 (Rupees -Ten Thousand) only pledged in the form of fixed deposit call deposit receipt or DD of any nationalized Bank in favour of Block Development Officer ,Jubaraj nagar R.D.Block otherwise, the quotation shall be rejected .The earnest money shall be released after 6(Six) moths of acceptance of rate .
- 5) Every quotation must be accompanied by a certified copy of the valid trade license, latest income Tax and Sale Tax clearance certificate issued by the appropriate authority .
- 6) The undersigned shall have absolute right to cancel or to change the quantity of supply order at any time without assigning any reason .
- 7) The name & contact no. of the owner /proprietor/ quotationer including address.Aadhar no. and bank A/c no. should be given along with the quotation .
- 8) Rate must include of all tax and charges for necessary loading ,unloading ,carrying ,weighing , counting and staking etc.
- 9) Necessary statutory deduction (Income tax, VAT etc) will be made from the bill at source and necessary TDS will be provided by the undersigned .
- 10) Bills are to be raised in duplicate to the undersigned after proper completion of supply in good condition .
- 11) In-complete, misleading or vague quotations are likely to be rejected.
- 12) Rates, as may be accepted ,will remain valid for one year and in the succeeding months till finalization of the next tender without any price variation .
